LINES OF COMMUNICATION

The correct procedure for any application to be made as follows.
An Individual must approach their Club Chair who will then pass it on to the Provincial Chair who then passes it up the Line.

Club Board → Provincial Board → ZAA Executive.

CLUB, AFFILIATION, AND PROVINCIAL AFFILIATION

- Should an archer wish to move clubs at any stage of the year, a clearance letter must be obtained from the club they are leaving.
- If archers are eligible to shoot for 2 provinces, i.e. parents reside in one province, but they attend school in a different province, they **MUST** select their SPORTING PROVINCE.

GENERAL SAFETY

The sport of archery must adhere to certain SAFETY RULES. The following is a list of some ideas and suggestions that are not restricted:

RANGE SETUP AND GROUP SAFETY CONSIDERATIONS

- Place the targets in an area completely without danger or at the foot of a small rise.
- Avoid placing the targets in front of a wall; arrows that hit into a wall will be severely damaged.
- If the chosen area presents any sort of danger (car park, neighbouring gardens, public paths, windows) do not hesitate to fix protection netting. (accredited netting – to world archery standards)
- There has to be a zone of 10 meters wide on each shooting side.
- All the archers must be located on the same shooting line.
- All archers must stop shooting if someone enters the shooting zone.
- All archers should shoot at the same time.
- Ensure that no archer is shooting with damaged equipment.
- Ensure that the archers move back several steps after having shot their arrows.
- Never pass in front of a line of archers; neither at close range nor at a distance.

INDIVIDUAL SAFETY CONSIDERATIONS

- All beginners should wear a forearm protector; this piece of equipment helps to prevent injuries and accidents.
- When in the shooting position, the string must be able to pass freely without obstructions. The clothing chosen for shooting should be adapted to this need.
- Do not use arrows that are too short; these can cause serious injuries to the archer if they fall from the arrow rest during shooting.
- Never use damaged bows, strings, or arrows; there is a risk of breakage to the equipment, that may cause injury.
- Never draw back the string and release it without an arrow; there is a risk of breakage to the equipment.
- Never point a bow towards someone, with or without an arrow.
- Never touch another archer when they are in the shooting position.
- Never shoot with the bow horizontally on the shooting line; the span of the bow can disturb other archers.
- Never shoot before everyone has returned to the shooting line.
- Never shoot an arrow vertically; it is impossible to know where the arrow will land.
- Do not stand behind an archer who is in the process of withdrawing the arrows from the target.
- Do not draw back or flex the bow, even without an arrow, while off the shooting line.
- Once on the shooting line, never collect an arrow unless it is possible to reach it with the end of the bow without moving the feet.
- When going to retrieve the arrows from the target, watch out for fallen arrows on the ground and approach the target from the side. Always walk.
- Do not withdraw the arrows from the target at the same time as another archer on the same target; there is a risk of being struck in the face by the arrow nock as the other archer withdraws the arrow.
- No broadheads on arrows to be used

IMPORTANT GROUND RULES APPLYING TO ALL ARCHERY EVENTS

- It is prohibited for archers or officials to consume alcohol prior and during any competition or practice.
- Spectators are not permitted on or near the shooting line – (3 meters behind the line) - during a competition there will be a demarcated area where spectators can view from.
- Archers are not permitted on the shooting line unless participating in an event.
- No Smoking is permitted on the shooting line or range. Only designated areas.
- All cell phones on the line must be switched off or on silent mode.
- All members or individuals associated with Archery in Zimbabwe must ensure and maintain the highest level of professionalism in the sport.
- Official Dress Code:
 - ZAA or Club Colours preferably golf shirts, sleeves must cover the shoulders
 - Shorts or longs
 - Closed in footwear
 - No Denim or Camouflage

FORMAT, INFORMATION, AND DUTIES FOR TARGET ARCHERY EVENTS.

All events will be held in accordance with World Archery events, as stated in the World Archery rulebook.

ELIGIBILITY

Every event is open to all archers registered with the Zimbabwe Archery Association through an affiliated body. As part of its contribution to the development of Archery in Zimbabwe, ZAA may allow schools to enter archers in junior and senior events. If these Archers wish to participate in ZAA National Championships they would need to affiliate themselves to a club, or affiliation and ZAA and pay the full affiliation fees.

INDEPENDENT / FOREIGN ARCHERS

Independent / foreign archers have to be registered Archers with a registered club and must have obtained clearance from that Club to participate in any ZAA event. A charge of \$100 per event will be levied to cover the costs of attaining clearances and other admin, as well as any competition fees that are applicable. These payments will be the individual Archer's responsibility.

AGE GROUPING

Age groups will be based on AGE AT 31ST DECEMBER of the year in which the event is being held. The age groups are:-

WORLD ARCHERY AGE GROUPS

- Under 15 Women;
- Under 15 Men;
- Under 18 Women;
- Under 18 Men;
- Under 21 Women;
- Under 21 Men;
- Women;
- Men;
- 50+ Women;
- 50+ Men;

DIVISIONS FOR WA TARGET ARCHERY

- Recurve Division;
- Compound Division;
- Barebow Division;
- Standard Bow Division (for Standard Round only).

DIVISIONS FOR WA 3D & FIELD ARCHERY

- Recurve Division;
- Compound Division;
- Barebow Division.

CLUB OR PROVINCE WA TARGET, 3D OR FIELD EVENTS AND CHAMPIONSHIPS

- Either 1 or 2 day, these events will be run as one event.
- Results are separated into relevant age groups and gender.
- Any Archery under 18 years must have an indemnity from a parent or legal guardian.
- Once started, archers will be expected to complete the events, should they be unable to, the Judge must be informed immediately.
- No Archer will be allowed to participate at more than one event without paying affiliation fees.
- Results, based on scores recorded, will be published by event and age group.
- Coaches/Archers to advise the Judge of any record attempts.
- Should the event be unable to finish due to thunderstorms, lightning, etc places will be awarded up to the time the event stopped.

SCRATCHINGS

Coaches may scratch an Archer at least 40 mins before the event. Penalties for no shows may be wavered should the archer present a Doctor's certificate or give adequate grounds for not reporting on time.

PROTESTS & APPEALS

From World Archery - Article 3.13.3 & Article 3.13.8

1. Article 3.13.3: An intention to appeal when it might affect the progression of an athlete from one stage of the competition to the next, must be expressed in writing and lodged with the Chairperson of the Tournament Judge Commission within 5 minutes of the end of the relevant round or match, whichever comes first. The written appeal must be lodged with the Jury within 15 minutes of the end of the relevant round or match, whichever comes first, to allow the Jury to come to a decision before the beginning of the next round of the competition.
2. Article 3.13.8: Jury decisions shall be minuted and submitted to the appeal, the Chairperson of the Tournament Judge Commission and the Organizers before the beginning of the next stage of the competition or before the awarding of prizes.
3. Protests must be submitted in writing with a deposit of \$50 to the Results Convener.

ZAA NATIONAL CHAMPIONSHIPS

- Archers must be members of a ZAA Affiliate or Club to take part in ZAA National Championships.

ARCHER ENTRY FEES

- Additional fees will be charged per archer to the club hosting Nationals; ZAA currently runs at a deficit, and these fees help make up the money needed for running the association.
- A \$10 “no show fee” will apply to individuals. It will be the responsibility of the club concerned to pay the ZAA Treasurer or Results Convener.

• Senior ZAA National Championships	\$10
• Junior ZAA National Championships	\$5

ENTRY PROCEDURES

- Entries should be prepared and submitted to the Results Convener at least 48 hours before the event. (IE; completed Google Form entries)
- Once entries have been sent to the Results Convener, no changes (by e-mail or SMS) may be done unless appropriate reasons given for alterations
- Late entries will only be accepted on the day by the Judge at his or her discretion.
- Lane draws will be done 24 hours before the event from the hat.
- Archers must report to the Judge 15 mins before the start of the event. – late arrival will start where the competition at and will either forfeit arrows missed, or continue into lunch, at the discretion of the Judge.
- Clubs may enter up to TWO teams per event per age group at the Host clubs discretion.

CLUB DUTIES

- All clubs need to organise the requested number of officials in advance of the event.
- All archers are requested to supply help or help in the running of 1 event each year.
- The Club running the event needs to organise refreshments throughout the morning and afternoon sessions.
- Manning the entrance gate/gates and accounting for the takings. These individuals are to be at the gates in good time (at least 1 hour before the event). The gates to be manned until interval, except in championships where the gates must be manned for the duration of the event. Gate taking are to be handed to the Treasurer of ZAA or, in his or her absence, any other member of the ZAA Committee.
- The host club is responsible for arranging a photographer and other media coverage for the event. However, the ZAA may provide assistance upon request. If the host club wishes to have the event promoted on ZAA platforms, all relevant marketing information must be shared directly with the ZAA Marketing team. The host club will remain liable for collecting any relevant permissions, and ZAA will comply with any reasonable take-down requests.
- Provide individuals to perform the following tasks.
 - Move, set up and dismantle targets, scoreboard, etc.
 - Lane allocation.
 - Supplying teas to officials and invited guests.
 - Assisting by providing 2 officials for the smooth running of the event.

MINIMUM SCORES AND NATIONAL TEAM SELECTION

- As part of the criteria for selection onto the ZAA team to shoot Nationals, archers should have shot individual events in at least 2 recognised events and have shot the Provincial Championships.
- Valid excuses such as a broken limb, surgical procedure, an infectious disease, a specialist's letter, or if they were representing their school or country in another sporting discipline at/during the entire time of the Provincial Championships. The excuse should be submitted, in writing with supporting documentation, to the ZAA Secretary BEFORE the relevant Championships for consideration for exemption.
- To qualify for the Zimbabwe National Target Archery Team, Archers must achieve the following Minimum Qualifying Score (MQS) either at ranking or at competition 3 times in a calendar year to maintain Zimbabwe National Target Archery Team status.

○ Compound Men U18	635 points/720 points
○ Compound Men U21	650 points/720 points
○ Compound Men (50m):	660 points/720 points
○ Compound Women U18	625 points/720 points
○ Compound Women U21	625 points/720 points
○ Compound Women (50m):	640 points/720 points
○ Recurve Men U18 (60m)	560 points/720 points
○ Recurve Men U21 (70m)	565 points/720 points
○ Recurve Men (70m)	595 points/720 points
○ Recurve Women U18 (60m):	540 points/720 points
○ Recurve Women U21 (70m):	545 points/720 points
○ Recurve Women (70m):	565 points/720 points

- Archers who have not achieved the Minimum Qualifying Score (MQS) may, at the discretion of the Selection Committee, be considered for selection in order to:
 - Ensure full team representation where required, and/or
 - Provide developing archers with valuable competition experience.
 - Such selections shall not prejudice or override the positions of archers who have met the MQS requirements.
 - Archers not meeting the MQS will wear the development kit while competing but will wear the full National kit for team events.

OLYMPIC, PARALYMPIC, AND YOUTH OLYMPIC GAMES QUALIFICATION

- Qualification spots for the Olympic, Paralympic, and Youth Olympic Games are awarded at the respective Africa Continental Championships held in the year preceding the Games. These spots are retained by the archer or team that secured them.
- In the event of injury or if the archer is unable to attend the Games, the qualification spot shall be allocated to the next eligible archer in accordance with the qualification criteria.
- Coaches and athletes intending to compete in the Olympic Games must adhere to the following timeline and reporting requirements set by the ZAA in coordination with the Zimbabwe Olympic Committee (ZOC):
 - 4 Years Before the Olympics: A long list of potential athletes must be registered with ZOC.
 - 2 Years Before the Olympics: Meetings with ZOC are held every two to three months, during which athlete updates are provided.
 - 1 Year Before the Olympics: Meetings become monthly, with regular athlete updates.
 - 6 Months Before the Olympics: All activities related to athlete health and well-being, including minor illnesses, must be recorded.
 - 3 Months Before the Olympics: Meetings increase to every two weeks.
 - Final Month Before the Olympics: Meetings are held weekly.

This structure follows the process established by ZOC for monitoring and supporting National Association athletes in their Olympic qualification journey.

ZAA NATIONAL TEAM INFORMATION AND DUTIES

- Archers shall at all times comply with the Code Of Conduct, and maintain an up-to-date WADA Certificate
- For archers traveling out of the country, a pre-tour meeting will be organised by SRC
- All marketing and media requests must be submitted directly to the ZAA Marketing team. This includes promotional content before the competition, media coverage during the event, and the sharing of post-competition results.

NATIONAL KIT

The current registered National kit is as follows;

1. White shirt with the front showing the Zimbabwe Flag colours down the right-hand side, with the Zimbabwe Bird on a Red Star on the left breast. The back displays, centrally, the Zimbabwe Bird on a Red Star with "Zimbabwe" underneath and the Archer's initial and surname, under that.
2. A design of angled green, yellow, and red stripes (reflecting Zimbabwe's national colors) comes across the front diagonally, with the Zimbabwe Bird on a Red Star on the left breast. The back displays in Yellow text the Archer's name and surname with "ZIMBABWE" underneath. Below the text, the diagonal stripes in green, yellow, and red continue, maintaining the same style as the front.

- The use of any other attire bearing the word "Zimbabwe," the National Emblem (Zimbabwe Bird on a Red Star), the Zimbabwe Bird, the Zimbabwe Flag, the Zimbabwe National Flower (Flame Lilly) or the ZAA Emblem is prohibited and shall result in the archer, coach, or representative being subjected to disciplinary action.
- All team archers, coaches, and representatives shall wear the same kit design while on the field of play.
- Kit designs for registration with WA must be submitted to ZAA no later than January 31 of each year.

SRC CLEARANCES AND END-OF-TOUR REPORTS

- Clearance to represent Zimbabwe must be submitted to ZAA for submission to SRC no less than 6 weeks before travel.
- Anyone who does not obtain clearance from SRC is not allowed to represent Zimbabwe.
- Archers representing *Flights or representing their Club at an international competition will need to submit a request with ZAA for WA registration no less than 30 days before the competition start date.
- **Any request for clearance shall be followed by a completed Competition Report submitted to ZAA no more than 1 week after the competition complete date**, for follow up with SRC. Failure to submit a competition report will result in forfeiture of any Clearance requests for the remainder of the year

AWARD OF COLOURS

- Archers must have been selected to represent Zimbabwe against other International Teams, not including Postal Shoots. Archers must have recorded at least three scores meeting the MQS, one of which must have been recorded in a World Archery registered competition. All scores to be recorded within a 12-month period.

CODE OF CONDUCT

1. All athletes, coaches, parents, and officials fall under the ZAA Manual for Disciplinary and Grievance Procedure. As a World Archery member federation, all individuals involved in Archery are also subject to the WA Code of Conduct
2. Clubs and Affiliates MUST submit, in writing, confirmation of lodging of completed Codes with the ZAA President before EVERY National. Failure to do so will mean non-participation of that archer.
3. We all have a responsibility to promote high standards of behavior in Archery.
4. As an archer, you have a big part to play. That is why ZAA is asking every archer to follow a code of conduct.
5. The ZAA Codes of Conduct apply to all Zimbabwe Archers Association members when participating in and administering the sport of archery. To protect the reputation of ZAA, the code also applies to those associated with ZAA or who are involved in archery whilst outside Zimbabwe.

EXPECTED MINIMUM STANDARDS OF BEHAVIOUR AND CONDUCT

As a ZAA member, I will:

1. Respect the spirit of fair play in archery
2. Adhere to the Rules of Shooting and the spirit of archery
3. Display and promote high standards of behaviour
4. Promote fair play – I won't cheat, complain or waste time
5. Endeavour to ensure the sport is enjoyable for everyone
6. Accept success and failure, victory or defeat with dignity
7. Be on time for training, competitions and events
8. Never engage in or tolerate public criticism of fellow archers, coaches or officials.

Respect the rights, dignity and worth of my fellow archers

9. Speak to my fellow archers, coaches, judges and officials with respect
10. Remember we all make mistakes
11. Always respect the confidentiality of other archers
12. Treat other people's data as I would wish them to treat mine
13. Always have the best interests of my fellow archers at heart.

Endeavour to ensure my own safety and the safety of others

14. Never participate when under the influence of alcohol or drugs
15. Place the well-being, safety and enjoyment of each archer above everything, including standards of performance
16. Protect others involved in archery from verbal or physical abuse and threatening or intimidating behaviour
17. Never engage in or tolerate offensive, insulting or abusive language or behaviour
18. Never engage in or tolerate bullying, intimidation or harassment
19. Never use or tolerate the use of social media (e.g. Facebook/Archery Interchange) to engage in bullying, intimidation or harassment.

Abide by ZAA Rules and Policies, including:

20. ZAA Safeguarding Policy
21. WADA Anti-doping rules

Take personal responsibility:

22. To update ZAA with changes to personal information

Breaking the Code of Conduct

23. By joining ZAA, everyone agrees to abide by this Code of Conduct, all ZAA policies, rules, regulations, and procedures.

ANTI-DOPING: MEDICATION IN SPORT

All archers wishing to compete in either ZAA Nationals Competition, AGA Zimbabwe Open Nationals Competition or Internationally with the ZAA National Target Archery Team, AGA National Team, or representing their club will need to complete the relevant National or International Athlete ADEL course from WADA and obtain a Certificate.

SHOOT CLEAN CAMPAIGN

World Archery is committed to the fight against doping and keeping archery clean.

Although archery is not considered to have a problem with doping, World Archery and its national archery federations are active in educating athletes, campaigning for fair play and protecting the integrity of the sport.

THERAPEUTIC USE EXEMPTIONS

Athletes may have conditions that require them to take particular medications. If this medication falls under the prohibited list, the athlete should apply for a therapeutic use exemption (TUE) that gives them authorisation to take the required medicine and continue to compete.

ZIMBABWE 720 RECORDS

National Records

- These are records held by citizens of Zimbabwe.
- To set a national record, the archer must gain the score at a WA registered competition, either in Zimbabwe or at an international competition that he/she has registered with ZAA to compete at.
- Example: If a Zimbabwean archer shoots the highest ever score by a Zimbabwean, it counts as a **Zimbabwe National Record**, even if a foreigner shot higher in the same competition.

This form should be completed and submitted by the respective National Sport Association for submission to the Sports and Recreation Commission within seven (7) days of completion of tour.

A. FOREIGN TOUR – ZIMBABWE TEAM/ATHLETE/OFFICIAL

1. The teams, athletes and/or officials undertaking sport and recreation tours in foreign countries represent the country. They fly the National Flag, sing the National Anthem and profile the country higher and higher each time such tours are undertaken. They are therefore ambassadors of the country.
2. The need to conduct themselves, in a manner that does not put the country into disrepute, cannot be overemphasized.
3. It is the responsibility of the Team Management to ensure that such conduct is upheld. Therefore the Head of Delegation has the overall responsibility of the team's conduct.
4. On return to the country after the tour of duty, it is the responsibility of the Head of Delegation to submit within seven (7) days of return, a report on the tour to show the conclusion of the project and lessons learnt.

B. TOUR OF ZIMBABWE – FOREIGN TEAM/ATHLETE/OFFICIAL

1. It is the responsibility of the National Sport Association to submit a report on the tour conducted by foreign teams, athletes and/or officials. It is their responsibility to enforce this requirement to their subordinate structures/affiliates.
